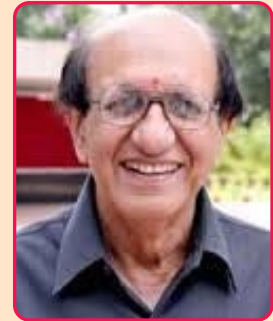

B.A. Part-I (Semester System)

Course Objective:-

After doing course student can appear in any competitive exam they can go for higher studies or there are options to get placement in Banking, Insurance sector & as a teacher etc.

Eligibility:

1. The candidate must have passed SSC-II, examination of the School Education Board of Punjab, Haryana, H.P. or C.B.S.E. or any other examination recognized by Punjabi University as equivalent there to.
2. Students having reappear in +2 exam are eligible to get admission in B.A.I only provided they must pass +2 exam before appearing for 1st semester examination.

Important Note: Candidates passing +2 from boards other than P.S.E.B., C.B.S.E., Himachal Pradesh Board of Education, Haryana Pradesh Board of Education, I.C.S.E. must produce eligibility certificate from registration branch of Punjabi University before taking admission in any graduation level class.

Important Instructions:

1. The students of B.A. Part-I class are allowed to change combination of subjects or faculty within a period of 1 Month from the date of admission by paying Rs. 50/- per subject and Rs. 200/- respectively. Students of BBA/BCA/B.Sc./B.Com can also change their faculty at first entry level within stipulated time.
2. No candidate for B.A. Part-I examination (under new scheme +3) shall take up the subject of Mathematics if he has not opted this subject in +2 examination.
3. The students who have passed the examination of Punjabi Parbodh from Languages Department Punjab will be considered equivalent to Matric Punjabi & will be eligible for the concerned course if they fulfil the rest of the conditions.

Regarding Taking Subject Punjabi Compulsory Mudhla Gyan instead of Punjabi* (For BA, B.Sc., B.Com Students):

1. The following categories of candidates shall be allowed to opt for the paper of Punjabi Mudhla Gyan in B.A./B.Sc./B.Com.& other related courses.
 - (a) Candidates who passed their Matriculation or 10+2 Examination from the schools/Institutions situated outside the state of Punjab.
 - (b) Children of Defence Personnel /Para-Military Personnel, the father or mother/guardian (in case the father of the candidate is deceased) will give a declaration that the candidate has not studied in Punjab at the School level.

As per instructions of Punjabi University vide its letter No. 5163-5308/G.C.-6, dt. 13-05-08 all students of B.A., B.Com. & B.Sc. shall have to study Punjabi in all three years of their respective degree courses.

ENVIRONMENT STUDIES & ROAD SAFETY AWARENESS

As per instructions of Punjabi University the paper of ENVIRONMENT STUDIES & ROAD SAFETY AWARENESS will be conducted in the fourth semester of B.A., B.B.A., B.Com, B.Sc. and B.C.A.

Eligibility:

The student should have passed at least 50% papers of B.A.-I Semester -I (New Scheme) of Punjabi University.

Note :

1. Every candidate shall take up the same combination of subjects as taken up by him/her in B.A. Part-I
2. A student who has passed B.A. Part-I from other University (GNDU & Panjab University) is eligible to take admission in Part-II.
3. A student who has opted for English Lit. in B.A.-I, can opt for Honours in English in B.A.-IInd year.

B.A. Part-III (Semester System)

Eligibility

The Students should have passed at least 50% papers of previous four semester exams.

Note: Every Candidate shall take up the same combination of subjects as taken up by him/her in B.A. Part-II.

The above list of fake Boards/Universities/Organizations is not exhaustive and there may be several other organizations which are not recognized for admissions at IMA.



Conditions For Admission :-

1. All admission for B.A./B.Sc./B.Com/B.C.A./B.B.A, M.A. (His.), M.Sc.(IT), M.Sc. (Maths), M.A. (English), M.Com & Other courses shall be provisional subject to approval/confirmation of admission by Punjabi University. The College shall not be responsible if university does not approve admission of any student due to wrong or incomplete particulars submitted by him/her or for want of any requisite document. Therefore before filling in the form, the candidate must ensure that he/she is eligible for admission to a particular class. If any ineligibility is detected at any stage, the admission shall be cancelled and college shall not be responsible in any case.
2. **The Principal reserves the right to refuse admission to any students whose behaviour was not found up to mark in the previous class.**
3. The Principal reserves the right to refuse admission to any student without assigning any reason.
4. The Principal can cancel the admission of any student who has been admitted to the college without assigning any reason what so ever.

General Rules for Admission & Reservation of Seats

1. Every Candidate seeking admission to the college shall possess a copy of the College Prospectus including the Admission Form, available from the College Office on payment of Rs. 250/- (Rs. 275/- by Post)
2. Every Candidate must complete the admission form in all respects along with attested copies of supporting certificates and two passport size photographs.
3. Every student is required to produce in original the university/Board Certificate of having passed the Previous Examination and a character certificate from the institution last attended.
4. Those who are already registered with the Board/University must produce their registration card at the time of admission.
5. In case any result is declared late by the University, a student can seek admission without late fee within 10 working days of the date of declaration of the result, subject to the availability of seats in that class.
6. A student belonging to scheduled or backward class is required to fill the necessary stipend form subject to income limits (Rs. 1,000,00/- p.a. for S.C. and Rs. 2,50,000/- p.a. for BC.) He/She will have to produce a certificate as proof of his/her belonging to the class concerned along with the income certificate from the competent authority.
7. a) Students from any other University/Board are required to furnish the original marks certificate of previous examination passed.
b) Students passing their lower examination from other University/Board are required to obtain and produce eligibility certificate issued by Punjabi University, Patiala

Reservation of Seats

A) According to the Punjab Government Letter No. 389 (S) - 99/7/87.c. (Edu) 3 dated 14.7.87 seats have been reserved for various categories of candidates as under :

1. Scheduled Castes	25%
2. Backward Classes	5%
3. Wards of Defence/CRPF/BSF/Police Personnel	2%
4. Sportsmen	2%
5. Wards of Edu. Dept. Personnel	2%
6. Handicapped	3%
7. Terrorist affected/Internal/External Migrants	2%
8. Children/Grand Children of Freedom Fighters	2%
9. Tsunami affected person	1%

B) On the recommendation of HRD Ministry, UGC has directed the Universities and their affiliated colleges to provide a minimum of 5% seats for foreign students in various courses.

C) Wherever minimum percentage of marks is prescribed for admission to a particular class, a relaxation of 5% will be allowed in the case of scheduled castes/backward class candidates.



IMPORTANT

(a) As per Punjabi University rules, one seat up to 50 students in a class and two seats having more than 50 students (Maximum Six in a college) will be reserved at entry point for the students on the basis of their performance in University Youth Festivals. The students applying against this Category shall be interviewed by the committee constituted by the Principal for this purpose.

(b) 10% additional seats in each class/course shall be reserved at entry point for poor & intelligent rural candidates. The list of such students shall be supplied by D.C. Office & the students seeking admission against this category shall be interviewed by the Principal of the concerned college and the university representative. Such students shall have to fulfil eligibility conditions.

(i) Students who have been detained/disqualified/failed in the same class will not be eligible to apply under this category.

(ii) Certificate of good conduct from the Principal of the institution last attended shall have to be submitted along with the application form.

(iii) These students shall have to secure minimum 60% marks in qualifying entrance test where ever applicable.

(iv) The students getting admission under this category will be entitled to fee and other concession as per the policy of the Punjab Govt./Punjabi University.





Admission To Re-Evaluation Cases :

A student whose result is declared late on account of re-evaluation can seek admission within 10 working days after the declaration of result subject to availability of seats.

Eligibility for University Examination

House Examination & Attendance for Graduation & Post Graduation Students.

To be eligible for Examinations :

- i) (a) For the students of all Graduation Courses and Post Graduation Courses eligibility conditions for appearing in exams will be as per Punjabi University Norms.
(b) A student should have obtained marks according to university rules and they have to appear in special test in case of failure to obtain minimum marks in house test.
- ii) A student must have attended at least 75% of the total lectures/practicals/tutorials in each subject. For genuine reason the Principal is empowered to condone shortage in attendance according to university norms. The Principal has right to detain the roll number of students according to university norms if student does not fulfil norms of attendance and marks in house tests.

Note : Under the Punjabi University regulations, students who do not fulfil the above conditions, cannot appear in the examination even as 'Private Candidates'

Payment of Fees & Funds

Common for all Students

The applicant must study the fee-structure before signing and submitting application for admission to a course. Fees and funds once paid will not be refunded in any case even though a student has not attended college for a single day. The college is not bound by any remedial claim, incidental or consequential, express or implied, accruing form fee, funds and other tariffs.

1. The security will be refunded in the month of November in the next session.
2. Security Not withdrawn up to 30th June of the following session shall lapse automatically.
3. All students coming on bicycles/scooters/motor cycles shall have to pay cycle/motor cycle fee for the entire session. Any student found evading the payment of fee will be charged double the normal fee.
4. If any student leaves the college without completing his/her

class/course, he/she shall have no claim whatsoever for the refund of fee.

- Any enhancement in fee and funds by the Pbi. University/Pb. Govt. Managing Committee/College authorities at any stage shall be binding on the students of all classes. The proposed revised fee structure, if any, will be notified to the students.

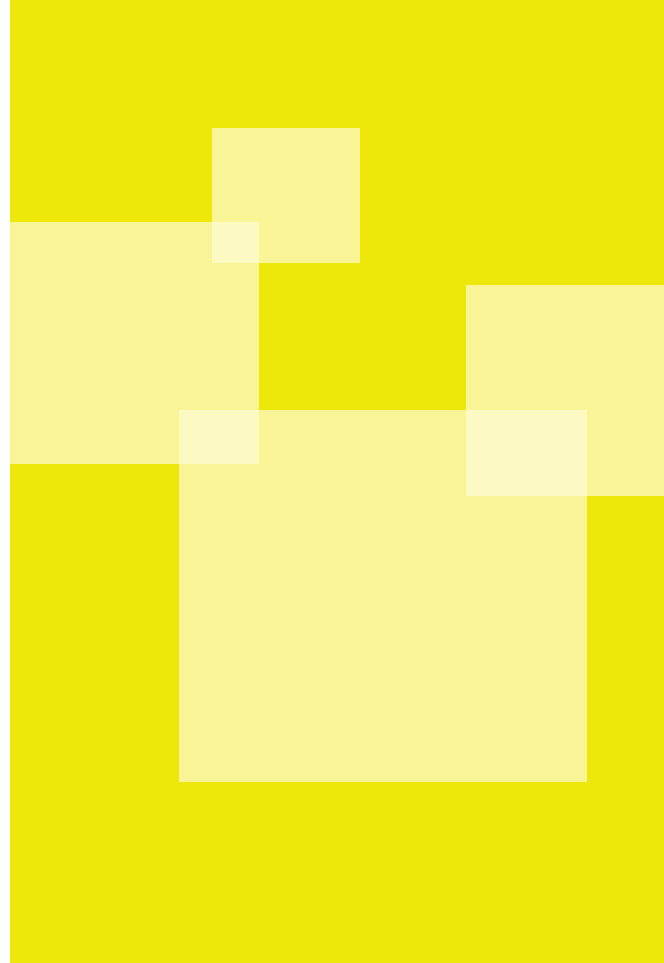

Important Note:-

1. Rs. 10/- per day late payment fine will be charged after the due date.
2. Those caught writing on the walls and black boards damaging college property including electric fittings, fans, taps, furniture etc. will be fined heavily. Cell phones will be confiscated.
3. 7 day absence will lead to striking off the name. Re-admission will be as per university/college rules at the discretion of the Principal.
4. Students caught taking drugs or try to bring outsiders will be fined heavily and can also be expelled.
5. Charges of absence per day will be Rs. 5/- in addition to the absentee fine prescribed by the university.
6. Fee once paid will not be refunded.
7. Student absent or on leave from the college must arrange to pay his/her fee on the due date.

Punjab Govt. Schemes for Scholarship & Fee Concession :

1. **Students of SC/BC/ST & Minority categories have to deposit fee at the time of getting admission/installment. They will get reimbursement after selection of their cases from Govt. of Punjab.**
2. Post Matric Scholarship Scheme for Minority Students - 2016-17 Students are advised to visit www.minorityaffairs.gov.in or get information from toll free number 1800-137-0015 or get information from college office regarding scholarship.
3. The Government has decided to extend educational concessions offered to the children of officers and men of the armed forces killed or permanently disabled during Indo-Pak and Indo-China conflicts, to the children of Defence Personnel, of Indian Peace-Keeping Force in Srilanka who have been killed or wounded. These concessions include complete exemption from tuition and other fees, full cost of books and stationery etc. Facility for free education will be available to the children of sufferers of certain categories as per Punjab Govt. Letter No. 19/2/87-EDU-1386-92 dated 30.04.90

Fee Concession at College Level:

1. Application for the concession on prescribed form obtainable from the college office should be submitted when called for.
2. Fee concession, stipend, scholarship etc. will be withdrawn in case a scholar deteriorates in studies, remains irregular in attendance or is found guilty of unfair means in any house test or examination.

Rules & Regulations Leave Rules

1. Leave for absence from the College should be applied for when absolutely necessary.
2. Leave should be secured personally before it is availed of. In case of serious illness, the leave application should be submitted immediately on returning to the college.
3. Leave application should be signed by the applicant's father/guardian.
4. A Medical certificate should be attached with the leave application in case of long illness.
5. Leave up to 6 days will be granted by the teacher incharge of various classes and for a period of more than 6 days by the Principal.

Rules for Sportsmen

1. No student shall be allowed to get himself registered with any club or team outside the college & play against the college. All sports activities in the college will be organized under college auspices only.
2. According to the University rules, the players will be permitted to participate in the University Tournaments only when they have attended at least 50% lectures in each subject from the date of admission in the college to the date of commencement of the tournament.
3. Sportsmen are expected to show exemplary behaviour and maintain discipline in the college. If a sportsman is found guilty of misbehaviour or breach of discipline inside or outside the college, he will be removed from the rolls of the college and all concessions given to him will be withdrawn with retrospective effect.
4. Players should be regular in attendance in their classes and maintain steady progress in studies. Their admission form will not be sent up for the University Examination if they fall short of lectures or fail to qualify in the House examinations according to the University Rules.

Rules of House Examination

1. The college will hold house examination as per Punjabi University rules. In addition to this class tests may be held.
2. It is compulsory for all students to appear in the House Examinations, and Tests. The absentees will be fined/detained according to rules.
3. The Examinees should be punctual. Late comers will be treated as absent from the examination.
4. Absence from examination for any reason will mean nil performance which may result in detention of a candidate from University examinations.
5. Leave from an Examination or test should be secured from the Principal well in time. No such application will be entertained after the Examination is over.
6. Leave from an Examination or test should be secured separately on prescribed form obtainable from the college office.
7. When a student falls ill, he should send his application for leave from the examination to the Principal immediately. The application should be supported by a medical certificate.

Career Counselling and Placement Cell :

The college has a Career Counselling and Placement Cell. The Career Counselling and Placement Cell provide students expert guidance regarding their career prospects and also work for their placement in jobs.

Cadets are trained for 'B' and 'C' Certificate exam. Students holding 'C' certificate are given priority in selection as an officer in Army, Air Force, Navy and Police, Students holding 'B' and 'C' certificate are given incentives and additional marks in various professional and higher classes for getting admission.**

National Service Scheme (N.S.S.)

The College has three units for boys and girls under the control of Punjabi University, Patiala The scheme is aimed at familiarizing the Youth with the environment of our community and its needs. It inculcates in students the spirit of placing service before self and the country above all.

The membership of the scheme is voluntary but it is desirable that more and more students should enroll themselves in the scheme. **Distinguished N.S.S. Volunteers are given incentives and additional marks in various professional and higher classes for getting admission.**

Sports Council

All sports activities are organized by the Sports Council constituted as under

1. Chairman (Principal)
2. Faculty members Nominated by the Principal as presidents of various games.
3. Captains of Various games.
4. Secretary (Lecturer in Phy. Education)

The outstanding sportsmen with a clean past career are given due consideration at the time of their admission to the college. Deserving scholars may be given fee concession and other facilities in keeping with their talent in sports.





Scheme for SC/ST Candidates

Conditions for eligibility to get financial help/aid from the Government as communicated by the D.P.I. for scheduled castes, scheduled tribes, backward classes and low income group students is as under :

Note : Students belonging to scheduled castes, scheduled tribes, Backward classes and low income groups studying in college and universities are eligible to get financial aid from the Government under following schemes :

1. Post-Matric Scholarship Scheme

Scheduled Caste students who are permanent resident of Punjab and are studying anywhere in India for Post-Matric education will be given Post-Matric Scholarship under this scheme provided that total annual income of the entire family from all sources does not exceed Rs. 2,50,000/-

Students of SC category have to deposit fee at the time of getting admission/installment. They will get reimbursement after selection of their cases from Govt. of Punjab.

3. STATE HARIJAN WELFARE SCHEME

Student Studying in Punjab State Colleges/Institutions who are Permanent residents of Punjab belonging to Backward Class will be given stipend under the scheme provided that the total annual income of the family does not exceed Rs. 44, 500/- under this scheme. Stipends are also paid to scheduled caste candidates. If the total income of the family is up to Rs. 1,00,000/-

4. SCHOLARSHIP SCHEME FOR SCHEDULED TRIBES

Students of scheduled tribes who are permanent residents of Punjab and are studying in Punjab or Chandigarh college will be given scholarship provided that the total income of the family does not exceed Rs. 5000/- and the total annual land revenue paid should not exceed Rs. 1000/-

5. SPECIAL GRANT TO GIRLS BELONGING TO SCHEDULED CASTES

Girls belonging to scheduled caste whose parents/guardians are permanent residents of Punjab and who are studying in Punjab and Chandigarh colleges will be given special grant for studies provided that total annual income of the family does not exceed Rs. 60,965/- subject to release of grant by state govt.

6. LOW INCOME GROUP SCHOLARSHIP SCHEME

Under this scheme students not belonging to scheduled castes, backward classes, scheduled tribes will be given scholarship provided that the total annual income of their parents does not exceed Rs. 24000/-. **It is to be noted that applications for all type of scholarships etc. will have to be sent to the Director of Public Instructions (C) Punjab, Chandigarh by 31st December every year.**

Free ship is given to scheduled caste, scheduled tribe and backward class students whose parent's income does not exceed Rs. 24000/- per annum and who have not failed more than once in the preceding class.

7. POST MATRIC SCHOLARSHIP FOR STUDENTS BELONGING TO THE MINORITY COMMUNITIES

Students belonging to Minority communities whose parents income is upto 2 Lac. per year and who have scored minimum 50% marks in the previous class can avail of this scholarship.

Prizes

1. The top scholar of each class and the best pass in each subject on the basis of the aggregate marks obtained by him/her in the House Examination provided that he/she gets a clear pass in each subject in the examination.
2. All students of the college who win University or Government Scholarship.
3. A gold medal will be awarded to the scholar of B.A./B.Sc./B.Com. Class of the college standing first in the University/Board examination.

General Prizes

General Prizes will be awarded to: 1. Best contributor to each section of the college magazine.

2. Best speaker in English, Hindi, Punjabi
3. Best social worker of the session.
4. Any other student, who in the opinion of the Principal has made a notable contribution to the maintenance of discipline in the college or brought any distinctive honour to the college.

Sports Prizes

Sports Prizes will be awarded to students winning distinction in athletics and games at the University / State / National Level.

College Colour

College colour will be awarded to :

1. Best actor of the year.
2. Best fine artist in the field of music, painting, photography etc.
3. Best N.C.C. cadet.
4. Best N.S.S. volunteer.
5. Best Youth Welfare worker.
6. Members of Punjab and India teams.
7. Student rendering meritorious services in Red Cross/Civil Defence activities.
8. Player of various games selected for the University teams.

Note : i) Prize will be awarded only if a student shows sufficiently high standard in his/her respective field and is considered and recommended by the concerned committee.
ii) Any student who has been punished for misconduct or found guilty of using unfair means in the House Examination will NOT be entitled to any Prize or College colour.

IDENTITY CARD

Every student is issued an identity-cum-library card which he/she is required to keep with him/her while in the college and also on all functions. In case the Identity Card/Library Card is lost, a written report should immediately be made to the Principal. A duplicate Identity card will be issued on payment of Rs. 75/- each.

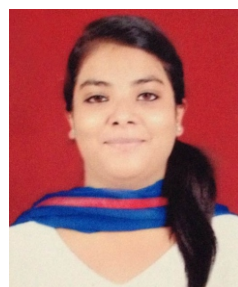

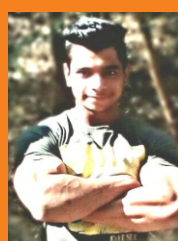

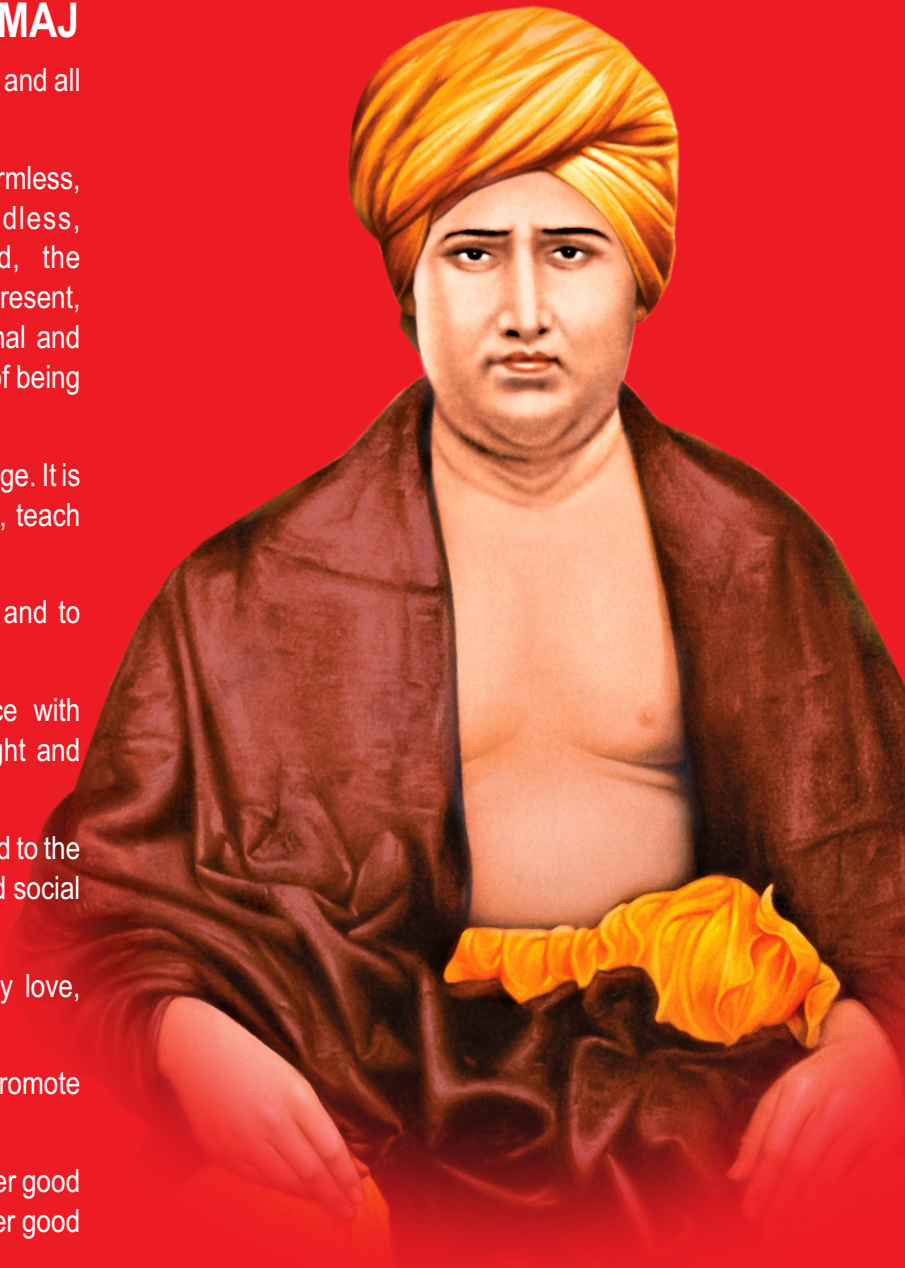
